Cambridge produces results transcripts using the name given for the candidate at the time of the exam. We will consider requests for minor amendments if all of the following requirements are met:

- a. The request is made clearly in an accompanying letter or email
- b. The amendment can be verified against the candidate's identification.

Completing the form - Check you have completed the following steps:

1. Type or complete the form in BLOCK CAPITAL letters using black ink.
2. Submit a photocopy of relevant identification which shows your name and date of birth in English.

Acceptable forms of identification are any one of the following:

- A photocopy or scanned copy of your birth certificate
- A photocopy or scanned copy of the photo page of your passport
- A photocopy or scanned copy of your driver's license
