Dear Parent/Guardian,

You are receiving this letter because your child participated in the Grade 10 English Language Arts Florida Standards Assessment during their 10th grade year, but did not earn a passing score of 3 or higher. **A passing score on this assessment is a requirement to earn a high school diploma.** All students who did not earn a score of 3 or higher will participate in the September and February Grade 10 FSA Retake Testing during the 2021-2022 school year for writing and for reading. You will be receiving a message alert with information regarding the Grade 10 FSA Retake when details are available.

In addition to these two retake opportunities, we will be offering a Non-College reportable ACT at St. Augustine High School on October 5th & 6th during the regular school day. We will offer the ACT Reading and English on the 5th and the ACT Math on the 6th. The cost of this test is \$35.00 for students and can be paid for on SchoolPay. Any student who participates in this ACT/NCR experience will be granted triple time on their test in the hope that this will give the student a better chance to acquire the necessary ACT concordant score for of an average of 18 on both the ACT Reading and English sections and if taking math the necessary ACT concordant score of 16 on the ACT Math section. Earning the ACT Reading/English concordant score will satisfy the Grade 10 FSA graduation requirement and earning the ACT Math concordant score will satisfy the Algebra 1 EOC graduation requirement. However, because these accommodations are not officially approved by ACT, results from this test experience will not be shared with colleges or scholarship agencies. It is worth repeating that the ACT scores earned during a non-college reportable ACT administration cannot be used for college admissions or scholarship purposes.

If you are interested in your child taking the ACT/NCR and would like to have practice materials other than what is provided in his/her Intensive Reading and/or math class, your child can access the free ACT preparation materials available through the ACT website at https://www.act.org/content/dam/act/unsecured/documents/Preparing-for-the-ACT.pdf.

Our goal is for 100% of our students to graduate with a standard high school diploma. We still are encouraging students to register for the Saturday ACT and SAT.
