

SAHS PSAT Reminder

Wednesday, October 23rd, 2024

On Wednesday, October 23rd, you will have the opportunity to take the PSAT/NMSQT® (Preliminary SAT/National Merit Scholarship Qualifying Test), an important step along your path to college. This testing is for current 10th graders and paid 9th and 11th graders. **(Registration is closed.)**

If you're a junior, the PSAT/NMSQT offers you the opportunity to qualify for scholarships that can help pay for college. For both sophomores and juniors, the PSAT/NMSQT provides great practice for the SAT®. You'll also get personalized feedback on your skills to help you improve them before taking the SAT.

In addition, you'll receive free college planning tools to help you start your college search and information on the types of AP® courses for which you may be particularly well prepared. These college-level classes can help you earn college credit and may give you a competitive advantage in the college admission process. The PSAT/NMSQT also connects you with colleges and universities across the country that are looking for students just like you. Just opt in to into Student Search Service® when you take the test.

This can also count for the Algebra 1 EOC if you have not yet passed the assessment. You must score at least a 430 on the Math Section.

IMPORTANT REMINDERS FOR

PSAT School Day

- All students that come to school on this day should be taking the PSAT. All other students can learn from home or go to the cafeteria for study hall.
- You must be at school on time. If you are late, you will not be allowed into testing room. There are no makeups for this test.
- You may bring your own **APPROVED CALCULATOR and NO.2 PENCIL**. A calculator is available in the digital program. <https://satsuite.collegeboard.org/psat-nmsqt/whats-on-the-test/math/calculator-use>
- It is recommended that you bring a snack, water, and lunch if staying after testing. There will be the option to purchase school lunch if needed.
- You can leave after testing **ONLY** if you have turned in the checkout form on the back of this sheet. **PLEASE RETURN TO MRS. JASPER IN THE MEDIA CENTER ON TUESDAY, 10/22, OR NO LATER THAN THE MORNING OF THE TEST.**
